#### Fluctuating Spring Temps...







What's New in the Park? In 2011, we are investing \$8 million in to the park. The expansion features three major projects:

Planet Snoopy--In August we announced that we would be expanding and renovating Camp Snoopy. Since the original announcement, the project has grown to feature six new attractions, a family care center and tons of midway renovations. The new attractions include a rocket ship kids coaster, tea cups, a hot air balloon



tower, monster trucks, a raceway and a twisting tug boat. In the New Planet Snoopy, parents will be able to ride with their kids on several of the new attractions.

- 2. The Grand Carousel--As you enter the park in 2011, your eyes will be drawn to a new addition in the Scandinavian section, The Grand Carousel. The nearly 100 year old carousel has been completely restored and features hand carved horses, dazzling jewels and vibrant colors. The attraction should be among the oldest and rarest in the World.
- 3. A New Festhaus Picnic Facility--Our largest catering pavilion, the Festhaus catering tent, was recently removed from the park in preparation for a brand new permanent structure. The new catering facility will feature a larger capacity, new amenities and a more secluded setting for meals.

Worlds of Fun, the Midwest's premier amusement park, announces additional capital projects for the 2011 season, highlighted by a complete restoration and installation of one of the world's most famous carousels, a new catering pavilion, and the previously announced Planet Snoopy.



In 1926, M.C. Illions meticulously carved 64 jumping horses and two chariots to create the **Illions** Supreme carousel, the most famous and reproduced carousel in the world. Known for their all wood horses with high swept manes adorned with jewels, only five original Supreme models were ever built by Illions. When installed at Worlds of Fun this spring, the carousel will be one of only two operating in the world!

Illions built the ride in 1926 for the Sesqui-Centennial Celebration held in Philadelphia. In 1927, it was moved to Birmingham, Alabama, and in the 1930's moved to Coney Island be restored. The carousel

operated at Geauga Lake in Aurora, Ohio, from 1937 to 2007, and now has been painstakingly detailed to its original condition by Carousel Works, Inc, Mansfield, Ohio, the largest manufacturer of carousels in the world. Guests will be able to watch the full restoration and installation of this beautiful ride in its entirety on 'Ultimate Restorations' (www.urtvshow.com).
